If a candidate decides to leave the internship, the candidate must inform the EPP within one week of the candidate's last day in that internship assignment.

NOTE TO DISTRICT/SCHOOL: If the employing district/school is notified of resignation/termination, or the EPP is notified of a resignation/termination, all parties must inform each other within one calendar week of the candidate's last day in the assignment. Texas Teachers will send a certificate deactivation request to TEA within two calendar weeks of the candidate's last day of the assignment.
